
## AREA 3

### Designation of the Termination of the Freeze Up Period Pursuant to Section 119 (2) of the Highway Traffic Act

---

The termination of the freeze up allowance contained in Section 119(2) of the Highway Traffic Act will commence on the 9<sup>th</sup> day of March, 2018 at 11:59 p.m. for those parts of Ontario situated:

All areas east of the City of Kawartha Lakes – Durham Region Line and the Durham Region – Northumberland County Line, and south of a line from Severn Bridge to the east side Highway 35 at Minden, thence northerly on the east side of Highway 35 to the south side of Highway 60, thence easterly on the south side of Highway 60 to Cache Lake thence, in a straight line including Highway 60 through Pembroke to the Ottawa River.
